This License applies to any Software licensed under the GNU General Public License.

You can use GNU GPL Software for any purpose. You can modify, copy and distribute GNU GPL Software, including derivatives, for commercial or non-commercial purposes.

## In return, you must agree:

- 1. That if you create a derivative of GNU GPL Software and choose to distribute it, you will distribute it under the terms of this License. This obligation arises only if you choose to distribute the derivative the mere fact that you have created a derivative does not give rise to any licensing obligations.
- 2. That if you distribute GNU GPL Software, you include two things: a copy of this license and a ready means of obtaining the source code for the Software.
